






### Patient Safety in Community Pharmacies



- More than 61,000 Community Pharmacies (2011)
- One estimate found 4 errors per day in a pharmacy filling 250 prescriptions daily (2002)
- AHRQ rationale was to support the development of a measurement tool for improving patient safety culture in community pharmacies.
